Agent McKinney conducted a full licensing audit on two licensees' files. He contacted Constable Thomas L. Selman who confirmed the condensed summary was correct. Constable Selman became the Chief Administrator on January 01, 2005 The "Racial Profiling Report" for 2020 has been filed. The RPR for 2012, 2013, 2014, 2015, 2016, 2017, 2018, and 2019 were filed as required. Changes to the F5R and the "My TCOLE Account" were discussed. Constable continuing education, officer training for the current two year unit and four year cycle, the background and personal history statement, and the law enforcement agency checklist were also discussed. No deficiencies were noted. There were no "Other" pay status appointments.
